V Public Hearing on the 2012/13 School Budget

The Board welcomed the public to the budget presentation. The SBA/BS discussed the budget in detail inclusive of the new procedure in adopting a budget for the 2012-13 fiscal year. The budget will see an increase of approximately \$9.50 per month for a home assessed at \$316,880.00. In addition, the Board will be presenting a 2nd question to the community at the November/2012 election. The 2nd question represents \$60,000.00 for the purchase of new technology. This is a one-time cost to the community and would benefit the students, staff and keep Farmingdale in compliance with State mandates for student on line testing (2014) and network compatibility.

Mrs. Crowl discussed the possible reduction in the \$9.50 per month, should the Borough receive a BPP reduction. The technology upgrade can also be beneficial for increasing the school's tuition students.

Mr. Dyevoich explained that the Board plans to make presentations regarding the second question to inform the community/public in support of this one time cost of \$60,000.00. This will enable our students to learn in different ways as well as keeping our students on par with the educational background of other districts.

The budget includes sufficient funds to provide curriculum and instruction, which will enable all students to achieve the Core Curriculum Content Standards, and is in compliance with N.J.S.A. 18A and N.J.A.C. Title 6 and 6A.

As per NJAC 6A:23B-1.2(b), the budget provides for a maximum expenditure amount that may be allotted for travel and expense

reimbursement. The 2012-13 budget includes a maximum travel appropriation of \$3,000.00 general fund and \$5,000.00 special revenue funds. The SBA/BS shall track and record these costs to insure that the maximum amount is not exceeded. Included in the 2012-13 budget is a maximum regular business travel amount of \$1,000.00 for specific employees.

RESOLVED, that the Farmingdale Board of Education includes the budget the automatic waiver adjustment for enrollment in the amount of \$21,647.00. The district intends to utilize this adjustment for supplies and materials necessary for the additional students.

RESOLVED, that the Farmingdale Board of Education includes in the budget the automatic waiver adjustment for increased cost of health benefits in the amount of \$2,252.00. The additional funds are included in the base budget and will be used to pay for the additional increases in health benefits.

BE IT FURTHER RESOLVED, that the Farmingdale Board of Education Public Question No. 1 be approved as follows:

Be it resolved, that there should be raised an additional \$60,000.00 for General Funds in the same school year (2012-2013). These taxes will be used exclusively for the purchase of new computers and technology equipment. Approval of these taxes will not result in a permanent increase in the district's tax levy. These proposed additional expenditures are in addition to those necessary to achieve the Core Curriculum Content Standards.

NOW THEREFORE, BE IT RESOLVED that the Farmingdale Board of Education hereby adopts the 2012-2013 school year budget.
